1. President's Column

Regio-centrism – did I just create this word – is one of the main obstacles in the development of social science. Euro-centrism for instance does not allow analysing or understanding societies from their own history, their own traditions and experiences, thus depriving sociology of the ability to explain global processes. Local culture influences and reacts on globalization processes. Knowledge of these cultures is therefore essential for sociological analysis.

In my current course on family sociology, I introduced students to the variety of family forms in the world, concentrating this time on the pairing up and marriage systems. We have a wonderful source in family sociology to do so. The book on "Handbook of World Families" edited by Bert Adams and Jan Trost provides us with information on families world wide. I would make it obligatory for any student of family sociology to have knowledge at least of one of the countries of each of the parts of the world dealt with in this book. My students were not only impressed with the variety of how people organise partnership in different countries, but they were also struck by the way in which education and urbanisation impact these processes.

In our research committee we always encourage participation world wide, giving a profound basis for the internationalisation of science. We will do so in the future. Sociology can only benefit from it.
